Remember

2. If you are a new Club Plus member you can only elect to invest your future contributions in the investment option/s of your choice. You can elect to invest your current account balance in different investment options after you have a positive account balance.
3. For your investment switch to become effectiveThe fully completed Member Investment Choice form must be received Monday through to Sunday to take effect on the Thursday of the following week.
4. You can make a switch at any time. You can make one free switch each six months. Any additional switch will incur a fee of \$35.
5. If you do not complete this form, or it is incorrectly completed, and you are a new member your investment will default, as outlined on page 7 of this Member Booklet (PDS). If you are an existing Club Plus member your investment will remain as per your existing election.
6. If you want to change your investment options at some time in the future you will need to complete and return a new form. This form can be obtained online on our website at www.clubplussuper.com.au or by calling Club Plus on 1800 680 627.
