Remember

3. For your investment switch to become effective, your completed Member Investment Choice form must be received by 4:00pm on any business day to take effect two business days after receipt.
4. You can switch between investment options without incurring switching fees, but a buy-sell spread applies - see 'Fees and Costs' in the *Investment Booklet* for the current buy-sell spreads for each option.
5. Please make sure you read the investment choice information in the *Industry Division Product Disclosure Statement (PDS)* and *Investment Booklet* and seek financial advice if necessary.
